Fayetteville Express Pipeline LLC ("FEP") submits herewith for filing with the Federal Energy Regulatory Commission ("Commission") the following revised tariff record to its FERC NGA Gas Tariff, First Revised Volume No. 1, proposed to become effective on August 1, 2025.

STATEMENT OF NATURE, REASONS AND BASIS

On January 30, 2025, FEP submitted its compliance filing in Docket No. RP25-410-000 ("January 30th Compliance Filing") in accordance with the Commission's Final Rule for Order No. 587-AA¹ which incorporated by reference the latest version of the business practice standards adopted by the Wholesale Gas Quadrant ("WGQ") of the North American Energy Standards Board ("NAESB"), Version 4.0, and the standard revised by Minor Correction MC24002. FEP herewith submits a correction to the "29. – Compliance with 18 C.F.R., Section 284.12" tariff record submitted in its January 30th Compliance Filing to include verbiage specifically related to Minor Correction MC24002 ("Correction Filing").

Attached hereto as Appendix A, FEP presents a redlined comparison between the versions of the tariff record submitted in its January 30th Compliance Filing (tariff record version 8.0.0) and this Correction Filing (tariff record version 8.0.1) which reflects the addition of the Minor Correction MC24002 language as related to NAESB WGQ Standard 3.4.1.

IMPLEMENTATION AND WAIVER REQUEST

Pursuant to Section 154.7(a)(9) of the Commission's Regulations, FEP requests that the proposed tariff record be accepted effective August 1, 2025, the implementation date of the NAESB Version 4.0 standards in accordance with Order No. 587-AA, and the same effective date which was requested in FEP's January 30th Compliance Filing. Additionally, as a result of this Correction Filing, FEP requests that the tariff record submitted in its January 30th Compliance Filing be rejected as moot.
